A Departmental Promotion Committee meeting was held on 20.12.2023 for promotion from the grade of Driver Grade-I to the grade of Driver (Special Grade) (Group C, Non-Gazetted, Non-Ministerial) on regular basis for the vacancy year 2024. 2. The above officer is directed to assume charge latest by 15.02.2024 failing which it will be construed that he is not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of OM No. 22011/5/86-ESTT. (D) dated 10.04.1989 shall be initiated.

3. The promotion shall take effect only after assumption of charge at the concerned Zone/place of posting. A copy of the assumption of charge should be endorsed to the Personnel & Estt. Section, New Custom House, Mumbai-I.

4. The pay and allowances of the newly promoted officer will be granted only from the date of assumption of charge. Promoted officers are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(1) (a)(i) as per DOPT OM No. 13/02/2017-Estt.(Pay-I) dt 27.07.2017 within one month from the effective date of their promotion.

5. The above promotion shall be subject to the outcome of any relevant pending case in any Tribunal/ High Court / Supreme Court of India and/or any review measure undertaken by this department in pursuance of any decision of any Tribunal/Court and/or any direction of the Ministry pursuant to any judicial order.

6. The controlling officer shall ensure that if any of the officers whose names figure in this order are under suspension or facing any charge-

sheet or prosecution, he/she should not be allowed to assume charge of the post and this should immediately be reported to the P&E Section, NCH, Mumbai Zone-I. Further, if any officer is undergoing any penalty, he/she should be allowed to assume the charge of the post only after the expiry of the currency of the penalty period and this should be reported to P&E section, NCH, Mumbai-I.
