It has been directed by the Competent Authority that the respective Controlling Officers shall ensure that all the officers are relieved by the above specified instructions and send a consolidated report of relieved and joined officers to the O/o the Deputy Commissioner of Customs, P&E, Mumbai Customs Zone-I by 19.01.2024.
