Dear Confeagues,

The e-way bill system is well under way with 20 days of roll out of the inter-state system and 12 states now covered under the intra-state e-way bill system. It is heartening to see that the implementation is going on smoothly and since its introduction on 1st April, 2018, more than one and a half crore e-way bills have been generated. After the roll-out of e-way bills for intra-state movement in six states, the average number of e-way bill generation has crossed eleven lakh per day. As and when the same gets implemented in other States, this number is expected to rise significantly. Hence, I would urge the Chief Commissioners of concerned zones to continuously monitor the progress and solve issues faced by any of the stakeholders on an urgent basis. I would also urge that in your State, if any particular area, commodity etc. is facing any genuine problem in implementation of the same, then, please coordinate with the State Tax Authorities for resolving the issues. Real-time monitoring along with providing immediate solutions will definitely help us in realizing our objective of making the process of doing business easy in our country.

I am happy to inform that Hyderabad zone has liquidated the appeals in Central Excise and Service Tax pending as on 30th June 2017. My heartiest congratulations to all the officers of the zone who have worked tirelessly to make this possible, particularly the Chief Commissioner of Hyderabad Zone, his two Commissioner(Appeals) and two Commissioner (Audit). Simultaneously, I would like other zones to also report on their progress in a regular manner and leave no stone unturned to reach zero pendency.

Another very important matter I would like to highlight is the large number of pendency of Returns marked for Review & Correction in ACES. In this regard Member (CX) has issued a letter dated 17th April, 2018 to all the Zonal Members to take up the issue with their respective Zones and get the pendency of such Returns reduced to NIL with a weeks' time. Action taken and progress made in this regard is being monitored on a daily basis by the concerned zonal Members who will in turn share their Zonal report with the Member (CX) by the 24th April 2018. Kindly do the needful at your end as instructed and honour the time line as indicated by your respective Zonal Members.

As you have been already informed, the last date to fill self-appraisal by the officer reported upon in SPARROW is 30th April, 2018. Kindly ensure that you do not keep the filing up till the last day.
