### **ESTT. OFFICE ORDER NO. 184/2025 (P&E)**

A Departmental Promotion Committee was held on 29.10.2024 for the Vacancy Year 2025 for promotion of Officers from the grade of Head Havaldar to the grade of Assistant Sub- Inspector (Weapons) (Group C, Non-Gazetted, Non-Ministerial) on regular basis. On the basis of the recommendations of the said DPC, the following Head Havaldar is hereby promoted to the post of Assistant Sub-Inspector (Weapons) in Level- 3 of 7 th CPC Pay Matrix (Rs. 21700- Rs.69100) on regular basis with effect from the date of assumption of charge of the post, not before 01.08.2025.

2. The promoted officer must assume charge not before 01.08.2025 and latest by 15.08.2025, failing which it will be construed that they are not interested in accepting the promotion. Failure to assume charge shall be treated as refusal to accept the promotion offered to the officer and action in terms of DOPT OM No. 22011/5/86- Estt.(D) dated 10.04.1989 shall be initiated.

3. The promotion shall take effect only after assumption of charge at the concerned zone/place of posting. A copy of assumption of charge should be endorsed to the Personnel & Estt. Section, New Custom House, Mumbai-I and respective Accounts Pay Bill Section of the Zones.

4. The pay & allowances of the newly promoted officer will be granted only from the date of assumption of charge. The promoted officer are entitled to exercise the option for fixation of pay on promotion in terms of F.R.-22(1)(a)(i) as per DOPT OM No. 13/02/2017-Estt.(Pay-I) dt 27.07.2017 within one month from the effective date of this order.
