The first fortnight Meeting of the Permanent Trade Facilitation Committee (PTFC) of Mumbai Customs Zone-I, for the month of November, 2025, was held on 13.11.2025 at 04.30 P.M. in the Conference Hall, 2nd floor, New Custom House, Mumbai. - 2. At the outset, the chairman extended his greetings and welcomed the representative from various PGAs and other stakeholders.
- 3. With the permission of Chair, Shri Vikram D. Phadke, Joint Commissioner of Customs (Import-I) informed that agenda point has been received for the day's meeting from MANSA and two pending points from previous PTFC meeting were also to be discussed.
- 4. Shri Domnic J Corriea, Senior Manager, MANSA stated that they are facing operational challenges on holidays for approval of port clearance, they requested for strengthening and integration of the existing Digital Port clearance system into a single window 24x7 clearance platform covering all vessel operation at Mumbai Port.

Shri Aslam Hassan, Commissioner of Export informed that officers are deputed on monthly basis for granting of permission of Port clearance on holidays with their contact numbers.

The chair directed Export/General Commissionerate to coordinate with MANSA and resolve their grievances.

5. Shri Neeraj Kumar Singh, Manager, Shahi Shipping informed that they would like restart bringing container under transhipment from JNCH to Mumbai Port via Barge for clearance of Mumbai port, for smooth clearance he requested that the scanning machine to be put into operation. He also requested that MbPA to provide berthing space and logistics support for Barge.

Shri Praful U. Kamble, Dy. Taffic Manager, MbPA appreciated the suggestion of shri Neeraj Kumar Singh and assured him full support possible.

Shri Vikram D. Phadke informed that the Board has asked all field formations to submit their requirements for container scanners. Accordingly, this office will be sending a request letter for the deployment of new scanners at Mumbai Port.

The chair directed to expedite the repair process and container scanner be made functional at the earliest.

6. Shri Vikram D. Phadke, Joint Commissioner of Customs (Import), again presented another pending point from the previous PTFC meeting regarding the absence of refer container handling and charging facilities at Mumbai Port.

In this regard, Shri Praful U. Kamble, Dy. Traffic Manager, MbPA informed that the representations had been received and are under consideration, however, he informed that MbPA needs concrete proposal like how many TEUs the importer likely to import accordingly arrangement will be done.

The Chair advised that a detailed and specific proposal be collected from the concerned importers outlining their requirements and suggestions, so that appropriate measures can be examined and initiated. 7. Shri Samir Sanghavi, Director, CN Sanghavi requested that some officers posted at import Docks be available at Indira Docks for examination and out of the charge of goods as the Trade find it difficult to depute their staff to go to MOD for getting Out of Charge and completing procedure. The chair assured that the request of the trade will be looked into.

8. Mrs. Ganguly, (AIWCBA), expressed her appreciation of CBLMS Section under leadership of Smt.Shraddha Joshi Sharma, Commissioner of Customs, additional charge of CBLMS Section(General), for the recent improvements in the processing and issuance of Customs Broker Passes, highlighting that the workflow has become significantly faster, more streamlined, and efficient.

As there were no further points for discussion, the meeting concluded with a vote of thanks to chair.
