In the Order-in-Original No.15/JC/DKT/ADJN/2025-26 dated 07.11.2025, para 29 (iv) may be read as :-

(iv) I impose penalty equal to differential duty of **Rs.6,44,775/- (Rupees Six Lakh Forty Four Thousand Seven hundred and Seventy Five only)** and applicable interest, on the importer M/s Madiha Trading Company (IEC No. EWBPS2362N) under Section 114 A of the Customs Act 1962, in respect of goods covered by Bill of Entry No. 9853531 dated 03.08.2022.
