**DETENTION NOTICE UNDER SECTION 142(1)(a)(b) OF THE CUSTOMS ACT, 1962**

**Subject:** Non-payment of confirmed demand amount of Rs. 3,50,000/- (Rupees three lakh fifty thousand only) as penalty to **Mohamed Zunaith Rasool Meera Maideen** vide Order-in-Original No. **KOL/CUS/ADC/PORT/MCH-PortBlair/103/2025** dated 20.06.2025.

Whereas, Mohamed Zunaith Rasool Meera Maideen, S/o- Meera Maideen, R/o- 18/3, Azasth Road, Pudur Ilayangudi Taluk, Sivaganga, Pin-630709, Tamil Nadu, India has failed to pay a sum of **Rs. 3,50,000/-** (Rupees three lakh fifty thousand only) as the demand was confirmed vide Order-in-Original No. KOL/CUS/ADC/PORT/MCH-PortBlair/103/2025 dated 20.06.2025 passed by the Additional Commissioner of Customs (Port), Custom House, Kolkata.

(2) Therefore, in exercise of the powers conferred by clause (a) of sub-section (1) of Section 142 of the Customs Act, 1962, I, the undersigned, Assistant Commissioner of Customs (Port) require and request that the aforesaid outstanding amounts should be recovered from any amount so payable from any money owing to the aforesaid parties/persons, which may be under the control of any officer of Customs or officers of the Central Excise/ Central GST all over India.

(3) I, also further require and request in terms of clause (b) of sub-section (1) of Section 142 of the Customs Act, 1962, that the aforementioned outstanding recoverable arrears should also be recovered by detaining and selling any goods belonging to the aforesaid parties/persons, which are under the control of officer of Customs or officers of the Central Excise/ Central GST formations all over India.

An intimation regarding the deduction/ recovery of the said amount may please be sent to the undersigned, and an email to [mch.port-blair@gov.in](mailto:mch.port-blair@gov.in) may also be sent as soon as the aforementioned amount is realised, for taking further necessary action in the matter. If a reply in this regard is not received within a month, it will be presumed that your jurisdictional Commissionerate has made no realisation.
