M/s. A. K. PAPER PRODUCTS (IEC No. 0905002873) have failed to pay a sum of Rs.3,00,839/- (Rupees Three Lakh Eight hundred and thirty-nine only) towards vide Bills of Entry (Bs/E) No.6445028/03.04.2012, 7141127 / 18.06.2012 and 8072900 / 28.09.2012 confirmed vide Order-in-Original No.03/2014 dated 26.11.2014. (Total Duty Demand Rs.300839/- with applicable interest.

Therefore, the undersigned in exercise of the powers conferred by clause (a) of Sub Section (1) of Section 142 of the Customs Act, 1962 do hereby require and request you that the aforesaid customs duty along with interest @ 15% per annum should be recovered from any money payable by you to the said importer. The amount so recovered may be sent to the undersigned by way of Demand Draft/Cheque drawn in favour of the "Commissioner of Customs", payable at Chennai. Any goods belonging to the said firm under your control may be detained & sold and the amount stated above may be deducted from the sale proceeds thereof. Intimation may be sent to the undersigned as soon as the money is realized. If the amount cannot be realized within a month, a report may be sent to the undersigned for taking further action in the matter.
