M/s. Yess Industries, (IEC- AGNPJ1349L) (Add: - Ground, 30, Kamathipura, 14th Lane, Mumbai Central, Maharashtra, 400008.) has failed to pay the following Government dues imposed vide Order-in-Original No. 1856/2023-24/DC/Grp. III/NS-III/JNCH dated 29.01.2024 passed by Deputy Commissioner of Customs, JNCH:

Therefore, in exercise of the powers conferred under clause (a) of sub-section (1) of Section 142 of the Customs Act, 1962, **I, Ankit, Deputy Commissioner of Customs, Appraising Group-III, Jawaharlal Nehru Custom House, Nhava Sheva**, hereby require and request that the aforesaid confirmed dues be recovered from any money payable to the said importer by all officers of Customs and/or officers of Goods and Services Tax (who have been designated as officers of Customs/GST) anywhere in India.

Further, in terms of clause (b) of sub-section (1) of Section 142 of the Customs Act, 1962, it is hereby directed that the said amount shall also be recovered by detaining and selling any goods belonging to the said party, by all officers of Customs and/or officers of Goods and Services Tax (who have been designated as officers of Customs/GST) throughout India.

The amount so recovered may be remitted to the undersigned by Demand Draft drawn in favour of "Commissioner of Customs, NS-III, JNCH", immediately upon realization.
