1. The officer, who was transferred in previous AGTs but not joined in their respective place of posting, should be relieved immediately.

3. Non relieving of any officer by the last date for exceptional administrative requirement shall be approved by the jurisdictional Commissioner and thereafter forwarded to the office of Pr. Commissioner (General), Mumbai Zone-I, with the approval of the Chief Commissioner of the concerned zone, for action at this end.
4. All the respective zones may issue their Intra-Zonal posting orders by 15.07.2025.
5. Officers at Sr. No. 3 & 9 of Annexure-A for transfer, who have not completed 03 years tenure in their respective zones, have been accepted by the Committee and these officers are to be posted only in non-sensitive postings in their respective Zones/Commissionerates, for their first one year of posting.
6. ASO & PSO (Appraising) sections of respective zones shall forward the compliance report regarding relieving and joining of officers latest by 01.08.2025.
7. All Appraisers transferred by this order to/from Outstation and coming from loan shall report to P & E Section, NCH, Mumbai before joining their next place of posting.
8. All representations/requests received so far from Appraisers regarding posting in AGT-2025 hereby stand disposed of.
9. It is the responsibility of the concerned controlling authorities to ensure non- sensitive charges/posting to the officers not clear from vigilance angle.
10. Officers already posted to sensitive charges/sections and transferred to a different zone in this order should be accommodated in non-sensitive postings for the first cycle of posting, as far as possible, as per policy.
