CIRCULAR NO. 21/2026

All concerned are hereby informed that the Annual General Transfers (AGT - 2026) in the grade of Appraisers & Examiners is under consideration, and accordingly, a circular no. 17/2026 dated 17.03.2026 was issued in accordance with the extant transfer and posting policy in the grade of Appraisers and Examiners, which is governed by Standing Order No.09/2017 dated 25.04.2017 as amended vide Standing Order No. 05/2022 dated 06.05.2022.

2. Representations were sought from all concerned to consider and accommodate requests from officers regarding posting to a specific zone, etc., based on spouse/dependent/medical grounds, etc., laid out in the policy. Further, Representations are also sought from the Appraisers posted to outstations regarding the reduction in the tenure of Outstation in terms of Standing Order No. 05/2022 dated 06.05.2022 on the basis of appropriate grounds.
