

## CIRCULAR No. 30

# Subject: Departmental Examination for promotion to the grade of Lower Divisional Clerks (LDC) for the officers namely Havaldar and Multi Tasking Staff of Central Taxes & Customs to be held in the month of June, 2025-reg.

As intimated by the Assistant Director, NACIN, Faridabad vide letter F. No. NACIN/Sys/13/2023-Exam-O/o Pr. DG-NACIN-Faridabad, the Departmental Examination for promotion of Havaldar and MTS to LDC of Central Taxes & Customs to be held on<u>16<sup>th</sup></u> <u>June, 2025</u>.

- 2. Eligibility criteria for Havaldar and MTS for appearing in the said examination as per Recruitment Rules of LDC is *two years regular service in the grade of Havaldar and Multi Tasking Staff (MTS) as per Recruitment Rules of LDC and DER-2024.*
- 3. The Question paper-II shall be in both English and Hindi. Candidates have the option to write the answer either in English or in Hindi. However, Paper-I will be in English and must be answered in English and Paper-III will be in Hindi and the same must be answered in Hindi. The Examination will commence at 10:00 hrs.
- 4. The application should be reached in the P&E Section, 2<sup>nd</sup> floor, not later than **30.05.2025** in the prescribed proforma (Annexure enclosed) by hand only. Application received after **30.05.2025** will not be entertained under any circumstances. Incomplete details may result in rejection of the application/form (Annexure 'C') without any further intimation to the officer.

Further, All the head of department are requested to bring this circular to the notice of all the concerned officers working under them, including those on leave, on deputation with other Directorate/ Organizations, so as the willingness of the candidates reaches in time to enable this department to conduct the examinations effectively.
