Attention of all importers, Customs Brokers and the members of the Trade is invited to Public Notice 217/2022 dated 10.03.2022 issued for empanelment of Chartered Engineers. Also, attention is invited to Public Notice 12/2025 dated 17.06.2025 regarding retention of Chartered Engineers in the panel for the inspection/examination of Second-hand/old & used machinery/goods etc. for technical opinion in the jurisdiction of Commissioner of Customs, New Customs House, Mumbai.

- 2. In this regard, a report has been received from SIIB referencing a case pertaining to Mumbai Docks, wherein it has been observed that the Chartered Engineer Mr. Mekala Naga Chaitanya failed to perform his duties diligently while certifying an old and used machinery.
- 3. In view of the above, the Competent Authority has decided to **temporarily de-panel** the Chartered Engineer Mr. Mekala Naga Chaitanya from the panel of Chartered Engineers for examination/valuation of second-hand machinery/goods etc. in the jurisdiction of the Commissioner of Customs (Import-I), New Custom

House, Mumbai, with immediate effect:
